

LAMINEX® NATURAL TIMBER VENEER PANELS

1. Subject to the conditions and limitations set out in this warranty below, Laminex Group Pty Limited A.B.N 98 004 093 092, trading as The Laminex Group, warrants to the original purchaser of any Laminex® Natural Timber Veneer Panels finished product for interior residential or commercial use that The Laminex Group will, at its option, repair or replace that product without charge if it fails directly as a result of a defect in its manufacture or materials used in its manufacture, during the first 7 years after initial purchase (proof of purchase will be required). Subject to paragraph 7, this obligation terminates at the expiration of 7 years from the date of purchase of the product concerned from The Laminex Group.
2. This warranty does not cover damage caused by:
 - a) any act of God, natural occurrence or any other circumstance beyond The Laminex Group's control; or
 - b) failure to follow any procedures recommended by The Laminex Group for the fabrication, installation and care of the Laminex Natural Timber Veneer Panels pre-finished product; or
 - c) physical abuse, misuse, accidents, exposure to excessive heat, exposure to excessive moisture, use of solvents or inappropriate cleaning products/ materials, improper maintenance, normal 'wear and tear'; scratches, scuffs, burns, stains, wipe marks on darker colour surfaces, exposure to chemical products; or
 - d) incorrect hinge installation and/or adjustment; or
 - e) general fading and discolouration and change in appearance due to direct and indirect light (exposure to direct sunlight should be avoided) (NB. Timber products, including Laminex Natural Timber Veneer Panels product, will react to direct and indirect light. Therefore, a change of the surface colour and appearance over time is a natural characteristic, not a defect. Additionally, heat and humidity will interact with light to accelerate the ageing process. If exposed to direct and strong light timber products may undergo sudden and irregular changes from the original colour as a little as an hour's exposure to sunlight may change the colour of timber.  - f) the product being used in applications that are not recommended by The Laminex Group in the product literature published by The Laminex Group; or
 - g) faulty workmanship by any person subsequent to supply of the Natural Timber Veneer Panels finished product from The Laminex Group; or
 - h) variation in colour, pattern, shade of the material against the sample material, displays and/or printed illustrations.

This warranty also does not cover:

 - i) anything which has been disclosed as a feature or limitation of the Laminex Natural Timber Veneer Panels finished product in any literature published or distributed by The Laminex Group;
 - j) outdoor application; or
 - k) where the defect is trivial or insubstantial; or
 - l) where, as at the date of notification of the defect to The Laminex Group, the type or colour of the alleged defective product no longer forms part of The Laminex Group's standard stock range and the person complaining of the defect does not agree to the supply of a replacement which is as close a type or colour match as is possible for The Laminex Group's then prevailing stock range.
3. This warranty applies only to Laminex Natural Timber Veneer Panels finished products:
 - a) purchased after 1 April 2001, for interior residential or commercial use in Australia;
 - b) which have not been moved from their original place of installation;
 - c) which have been installed, maintained, used and protected in the manner recommended by The Laminex Group in its published literature concerning those products, a copy of which may be obtained, free of charge, or by writing directly to

- The Laminex Group at the address given below;
- d) where The Laminex Group has been notified of the defect within seven days of the first person to become aware of it.
 4. This warranty is limited to the repair or replacement of any Laminex Natural Timber Veneer Panels finished products, covered by this warranty and does not include any field labour charges, or any consequential or economic loss, or loss of profits, or damage, including those suffered through or resulting from defects, caused by faulty manufacture or faulty material.
 5. A replacement product from The Laminex Group may not be reasonably available in the same shape or species as the original Laminex Natural Timber Veneer Panels finished products covered by this warranty. If a replacement product of the same shape or species is not reasonably available, The Laminex Group reserves the right to provide a replacement product as close in shape and species as is reasonably possible from The Laminex Group's then prevailing product range in satisfaction of its obligations under this warranty.
 6. Except as expressly provided in paragraphs 1 and 7, all terms, conditions, warranties, undertakings, inducements and representations, whether express or implied, statutory or otherwise relating in any way to any Laminex Natural Timber Veneer Panels finished products are excluded. Without limiting the generality of the preceding sentence, The Laminex Group will not be under any other liability in respect of any loss or damage (including consequential loss or damage) however caused (whether by negligence or otherwise) which may be suffered or incurred, or which may arise directly or indirectly in respect of any Laminex Natural Timber Veneer Panels finished product.
 7. Where applicable legislation implies any term, condition or warranty into The Laminex Group's relationship with a person who has acquired any Laminex Natural Timber Veneer Panels finished product, or otherwise gives that person a particular remedy against The Laminex Group, and that legislation or any legislation voids or prohibits any provision excluding, or modifying the application of, or the exercise of, any liability under such term, condition, warranty or remedy, such term, condition, warranty or remedy shall be deemed to be included in or, as the case may be, apply to that relationship. However, The Laminex Group's liability for any breach of such term, condition or warranty, or under such remedy, shall be limited, at The Laminex Group's option, in any one or more of the ways permitted by the legislation, including, where so permitted:
 - a) If the breach relates to any Laminex Natural Timber Veneer Panels finished product:
 - i. The replacement of that Laminex Natural Timber Veneer Panels finished product or the supply of equivalent Laminex Natural Timber Veneer Panels finished product;
 - ii. The repair of that Laminex Natural Timber Veneer Panels finished product; or
 - iii. The payment of the cost of replacing that Laminex Natural Timber Veneer Panels finished product or acquiring equivalent product.
 - iv. The payment of the cost of having that Laminex Natural Timber Veneer Panels finished product repaired.
 8. Please note that in addition to this warranty the law may confer on you, rights arising out of the supply of Laminex Natural Timber Veneer Panels finished products. This warranty should therefore, not be read as an exhaustive statement of the rights of the original purchaser or any other person.
 9. This warranty does not cover any other product used or installed in connection with Laminex Natural Timber Veneer Panels.
 10. This warranty is not transferable or assignable.
